ADMINISTRATIVE ORDER 2020-6

RE: COVID-19 EMERGENCY MEASURES –RESCHEDULING May 18 through May 29, 2020

IN CONJUNCTION WITH CHIEF JUDGE TIMOTHY EVANS' GENERAL ADMINISTRATIVE ORDER: 2020-01 (amended as of May 1, 2020), the Presiding Judge of the Second Municipal District, Shelley Sutker-Dermer, has rescheduled court matters from May 18, 2020 through and including May 29, 2020. This Order supersedes prior Administrative Orders issued by this District.

IT IS HEREBY ORDERED:

- 1. TRAFFIC and MISDEMEANOR: All traffic and misdemeanor cases scheduled from May 18, 2020 through and including May 29, 2020 will follow the same key date and are continued as follows:**

- 2. CRIMINAL:**

A. FELONY: All Out-of-Custody Arraignments and Emergency Felony Motions from Courtrooms 107, 108, 206, 207, 208 and 209 will be conducted in Courtroom 108 via videoconferencing.

All Preliminary Hearings, Bond Hearings and In-Custody Arraignments will be conducted in Courtroom 105. All aforementioned proceedings involving In-Custody Defendants will be conducted in 105 via videoconferencing.

All Emergency Misdemeanor Motions, Emergency Orders of Protection, Emergency Civil No Contact Orders, Emergency Stalking No Contact Orders, and Additional Preliminary Hearings will be conducted in Courtroom 106 via videoconferencing.

No warrants will be issued for failure to appear in court from the effective date of this order through and including May 29, 2020.

All felony matters scheduled in Courtroom 107, 108, 206, 207, 208, and 209 from May 18, 2020 through and including May 29, 2020 are continued as follows:

Cases set for May 18, 2020 are continued to June 26, 2020.

Cases set for May 19, 2020 are continued to June 29, 2020.

Cases set for May 20, 2020 are continued to June 30, 2020.

Cases set for May 21, 2020 are continued to July 1, 2020.

i. Drug Court:

3. **DOMESTIC VIOLENCE:** Emergency or Interim Orders of Protection, any Emergency or Interim Stalking No Contact Orders, and Emergency or Interim Civil No Contact Orders that are set to return and/or expire on May 18, 2020 through and including May 31, 2020 shall be extended and rescheduled as provided by the Administrative Order 2020-DV-02 (amended May 1, 2020) entered by Presiding Judge of the Domestic Violence Division, Raul Vega.
4. **DOMESTIC RELATIONS:** All emergency matters will be heard in the Domestic Relations Division in the Richard J. Daley Center, 50 W. Washington St., Chicago in Courtrooms 1903 and 1905 and all set matters will be continued as provided by the Administrative Orders entered by the Presiding Judge of the Domestic Relations Division, Grace Dickler.
5. **CIVIL:**
Law Division: Cases before Judge Jeffrey Warnick in Courtroom 202 will be heard as assigned via Zoom videoconferencing-- Meeting ID: 925-0801-8507 or via telephone 312-626-6799 as of the date of this order.

Municipal Division: All municipal cases scheduled for May 18, 2020 through and including May 29, 2020 in Courtrooms 202 and 204 are stricken other than emergency matters. After June 1, 2020, parties may motion up their cases to be heard or will be notified by the Clerk's Office of a new date.

6. **MANDATORY ARBITRATION:** All hearings scheduled through and including May 29, 2020 are cancelled and will be rescheduled. Parties shall be notified.

7. **EXPUNGEMENTS:**

Hearings originally scheduled for April 7, 2020 and April 14, 2020 are continued to June 11, 2020 in Room 102 at 1:30 p.m.

Hearings originally scheduled for May 8, 2020 and May 15, 2020 are continued to June 18, 2020 in Room 104 at 1:30 p.m.

Hearings scheduled for May 21, 2020 are continued to June 24, 2020 in Room in 101 at 1:30 p.m.

Parties shall be notified if hearings will be proceeding via Zoom videoconferencing.

8. **PETITIONS FOR POST-CONVICTION RELIEF:** All hearings that have been previously set on days other than Friday will be rescheduled to a Friday with parties to be notified.

9. **JUVENILE JUSTICE DIVISION:** Juvenile detention hearings and demands for trial will be conducted daily at 1100 S. Hamilton Ave., Chicago.

10. **MARRIAGES:** All marriages that have been scheduled through and including May 29, 2020 are cancelled.
