RE: COVID-19 HEALTH AND SAFETY MEASURES FOR THE RESUMPTION OF COURTHOUSE OPERATIONS

IN CONJUNCTION WITH CHIEF JUDGE TIMOTHY EVANS' GENERAL ADMINISTRATIVE ORDER: 2020-02 AND IN RECOGNITION OF THE CONTINUING NEED TO ADHERE TO HEALTH AND SAFETY PROTOCOLS IN RESPONSE TO THE COVID-19 WORLD PANDEMIC, the Presiding Judge of the Second Municipal District, Shelley Sutker-Dermer, resumes courthouse operations, remotely as reasonably possible, at the Second Municipal District, effective July 6, 2020, as follows:

IT IS HEREBY ORDERED:

1. TRAFFIC AND MISDEMEANOR:

Courtroom 102 will hear all traffic and misdemeanor emergencies, arranged dispositions, and the resetting of cases from Courtrooms 101 and 102 to a later date. All matters will be heard via Zoom at 9:00 a.m. No defendants are required to appear unless instructed to do so and will be notified by the Clerk's Office of a new date. Police Officers are to appear only if notified by the prosecuting agency. Courtroom 102-ZOOM MEETING ID: 994-3602-5343; ZOOM PASSWORD: 756943. ZOOM via Telephone: Dial 312-626-6799 and enter MEETING ID and PASSWORD provided above.

Courtroom 104 will hear all traffic and misdemeanor matters from both Courtroom 103 and 104 to reset cases to a later date or to hear arranged dispositions. All matters will be heard via Zoom at 9:00 a.m. No defendants are to appear unless instructed to do so and will be notified by the Clerk's office of a new date. Police Officers are to appear only if notified by the prosecuting agency. Courtroom 104-ZOOM MEETING ID: 910-7264-7468; ZOOM PASSWORD: 228880. 2. CRIMINAL:

A. FELONY:

All matters in Courtrooms 107 and 108 will be heard in 108 at 10:00 a.m.

All matters in Courtrooms 206 and 207 will be heard in 206 at 9:00 a.m.

All matters in Courtrooms 208 and 209 will be heard in 208 at 9:30 a.m.

These courtrooms will operate remotely via Zoom to the extent as reasonably possible.

BONDS AND PRELIMINARY HEARINGS will be heard in Courtroom 105 at 9:00 a.m. remotely via Zoom to the extent as reasonably possible.

Courtrooms 101, 103 and 107 are designated for defendants/counsel to appear remotely via Zoom when at the courthouse for the calls conducted by Courtrooms 102, 104, 105, 106 and 108.

Courtroom 207 is designated for defendants/counsel to appear remotely via Zoom when at the courthouse for the calls conducted by Courtrooms 206 and 208.

B. PROBLEM SOLVING COURTS:

All Problem-Solving Courts, (Drug Court, Mental Health Court and Veteran's Court) will be conducted remotely. Parties/counsel will be notified of dates and instructions for proceeding remotely.

3. DOMESTIC VIOLENCE DIVISION:

Courtroom 106 will conduct the Domestic Violence Call remotely via Zoom pursuant to the Protocol document of Judge Saltouros which may be found on the Circuit Court of Cook County website, www.cookcountycourt.org under the Second Municipal District. Counsel/litigants should not come to the courthouse.

4. DOMESTIC RELATIONS DIVISION:

Courtroom 203 will conduct its Domestic Relations calls remotely via Zoom pursuant to the Administrative Orders entered by Presiding Judge of the Domestic Relations, Grace Dickler which can be found on the Circuit Court of Cook County website, www.cookcountycourt.org. Counsel/litigants should not come to the courthouse.

5. CIVIL DIVISION:

Courtrooms 202 and 204 will continue to conduct their Civil calls remotely via Zoom pursuant to the Protocol document of Supervising Judge Jeffrey Warnick, effective June 1, 2020 which can be found on the Circuit Court of Cook County website, www.cookcountycourt.org under Second Municipal District. Counsel/litigants should not come to the courthouse.

6. MANDATORY ARBITRATIONS:

All mandatory arbitrations scheduled from March 17, 2020 through and including July 6, 2020 will be rescheduled.

7. EXPUNGEMENTS:

All expungement matters will be heard remotely in Courtroom 108 and counsel/defendants will be notified of hearing dates. 8. JUVENILE JUSTICE DIVISION:

All matters will be conducted daily either remotely or in-person at 1100 S. Hamilton Ave., Chicago.

9. MARRIAGES:

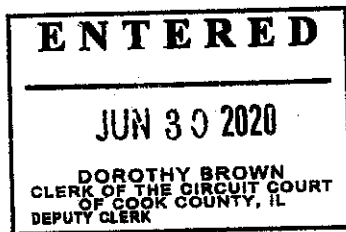
All marriages will be performed by appointment only. No more than 4 guests allowed. Appointments may be made by contacting the Presiding Judge's Office at 847-470-7200.

ZOOM INSTRUCTIONS: To download ZOOM on a laptop or desktop, go to <https://zoom.us/download> and select Zoom Client for Meetings. Once the download is complete, open up the application and select Join a Meeting. Enter the MEETING ID and PASSWORD that corresponds to the courtroom to which your case is assigned. The ZOOM application may be downloaded on a smartphone or mobile device and the procedure is the same. Access to Zoom via telephone: Dial 312-626-6799 from a telephone and follow the prompts. The MEETING ID and PASSWORD for each courtroom are provided above.

Any and all recordings, video/audio tapings, photographing or otherwise reproducing, saving or distributing any remote ZOOM proceedings of the Second Municipal District are strictly prohibited pursuant to Illinois Supreme Court Rule 63(A)(8). Zoom Meeting ID and Passwords to access court calls may only be used on your scheduled court date and time.
