ADMINISTRATIVE ORDER 2020-4

RE: COVID-19 EMERGENCY MEASURES –RESCHEDULING ENLARGEMENT

IN CONJUNCTION WITH CHIEF JUDGE TIMOTHY EVANS' GENERAL ADMINISTRATIVE ORDER: 2020-01 (amended as of March 30, 2020), the Presiding Judge of the Second Municipal District, Shelley Sutker-Dermer, has rescheduled court matters from April 16, 2020 through and including May 15, 2020.

IT IS HEREBY ORDERED:

1. TRAFFIC and MISDEMEANOR: All traffic and misdemeanor cases scheduled from April 16, 2020 through and including May 15, 2020 are continued to the next Key Date.

2. CRIMINAL:

A. FELONY: All Arraignments and Emergency Felony Motions from Courtrooms 107, 108, 206, 207, 208 and 209 will be conducted in Courtroom 108.

All Preliminary Hearings, Bond Hearings, Arraignments will be conducted in Courtroom 105. All aforementioned proceedings involving In-Custody Defendants will be conducted in Courtroom 105 via Zoom. Procedures and protocol for accessing Zoom are forthcoming.

All Emergency Misdemeanor Motions, Emergency Orders of Protection, Emergency Civil No Contact Orders, Emergency Stalking No Contact Orders, and Additional Preliminary Hearings will be conducted in Courtroom 105 via Zoom. Procedures and protocol for accessing Zoom are forthcoming.

No warrants will be issued for failure to appear in court from the effective date of this order through and including May 15, 2020.

All felony matters scheduled in Courtroom 107, 108, 206, 207, 208, and 209 from April 16, 2020 through and including May 15, 2020 are continued as follows:

iii. Veterans' Court:

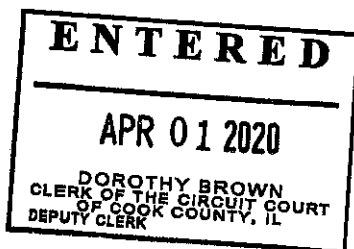
All matters are continued to May 22, 2020.

DOMESTIC VIOLENCE: Emergency or Interim Orders of Protection, any Emergency or Interim Stalking No Contact Orders, and Emergency or Interim Civil No Contact Orders that are set to return and/or expire on April 16, 2020 through and including May 15, 2020 shall be extended and rescheduled as provided by the Administrative Order 2020-DV-03 entered by Presiding Judge of the Domestic Violence Division, Raul Vega on March 31, 2020.**

4. **DOMESTIC RELATIONS:** All emergency matters will be heard in the Domestic Relations Division in the Richard J. Daley Center, 50 W. Washington St., Chicago in Courtrooms 1903 and 1905 and all set matters will be continued as provided by the Administrative Orders entered by the Presiding Judge of the Domestic Relations Division, Grace Dickler.
5. **CIVIL:** All matters will be rescheduled pursuant to Second Municipal District Administrative Order 2020-05.
6. **MANDATORY ARBITRATION:** All hearings scheduled from April 16, 2020 through and including May 15, 2020 are cancelled and will be rescheduled.
7. **EXPUNGEMENTS:** All hearings that have been scheduled through May 15, 2020 will be continued to May 21, 2020 at 1:30 p.m. in Room 101.
8. **JUVENILE JUSTICE DIVISION:** Juvenile detention hearings and demands for trial will be conducted daily at 1100 S. Hamilton Ave., Chicago.
9. **MARRIAGES:** All marriages that have been scheduled through and including May 15, 2020 are cancelled.
