EVICTION CASE ASSIGNMENT

Pursuant to Chief Judge Evans' ERP Order, all matters will receive an initial court date in Room 209 on Tuesday and Thursday afternoons. The cases shall proceed through 209 until they are referred for trial.

When the court determines a case is ready for trial referral, it shall transfer the case to the appropriate trial room according to the following schedule:

- Case numbers ending in 0, 1, 2 or 3 shall be referred to Room 209 (MONDAYS ONLY) for trial setting. The parties or ERP staff shall provide the appropriate trial referral order (attached) to the court immediately upon referral of the case to the trial room.
- Case numbers ending in 4, 6 or 8 shall be referred to Room 208 (TUESDAYS AND THURSDAYS ONLY) for trial setting. The parties or ERP staff shall provide the appropriate trial referral order (attached) to the court immediately upon referral of the case to the trial room.
- Case numbers ending in 5, 7 or 9 shall be referred to Room 207 (TUESDAYS AND THURSDAYS ONLY) for trial setting. The parties or ERP staff shall provide the appropriate trial referral order (attached) to the court immediately upon referral of the case to the trial room.
