
**SUBJECT: PENDING FEE WAIVERS IN DISPOSED CASES**

Mandatory e-filing went into effect on July 1, 2018 which included mandatory e-filing of Illinois Supreme Court Rule 298 fee waiver applications. Since that implementation, some electronically filed fee waiver applications remain pending.

**IT IS HEREBY ORDERED:**

1. The Clerk of the Circuit Court of Cook County shall strike from the record all pending fee waiver applications in cases that meet the following criteria:
  - (a) The case has one or more fee waiver applications that were filed between July 1, 2018 and August 23, 2019;
  - (b) The case has a dispositive order entered which ended the case; and
  - (c) The case is identified on the attached list.
2. The Clerk of the Court shall not seek any payment for any unpaid filing fees in cases where the fee waiver is stricken.
3. Any other fee waiver applications that remain pending in active cases will be handled in accordance with Chancery Division procedures and General Administrative Order 2018-06 entered by Chief Judge Timothy C. Evans.
