Access Living is a disability rights organization. Its Civil Rights Team provides legal assistance to people who have been discriminated against due to a disability. It focuses on two areas: (a) discrimination in securing or maintaining housing, and (b) discrimination in gaining access to and using the services of a private business that is open to the public. An example of a case of housing discrimination would be a situation where a landlord refuses to waive a "no pets" policy for a tenant with a vision disability who relies on a guide dog to get around. An example of a case of discrimination related to a private business would be a situation where a restaurant does not have an accessible bathroom or refuses to serve someone who uses a wheelchair.

CGLA provides free legal services in the areas of housing, family, and criminal law.

In **Housing Law**, the focus is on representing individuals facing eviction from subsidized housing or Housing Choice Voucher (Section 8) terminations at both the administrative hearing and Chancery court (appeal) levels. Eviction and voucher termination cases must involve allegations of criminal activity. We also assist individuals denied admission into subsidized housing based on their criminal record.

In Family Law, the focus is on providing legal services to clients who are currently incarcerated or under correctional control. At this time, we are only scheduling intake appointments for respondents in orders of protection where the order negatively impacts their access to their children, their housing or their employment. We are only accepting other family law cases (i.e., divorces, custody and visitation, minor guardianships) from partner agencies.

In **Chicago Legal Advocacy for Incarcerated Mothers** (**CLAIM**) program, we provide legal aid for child custody and visitation, guardianship of minors, discharge of guardianship, divorce, foster care, and parentage matters for incarcerated or formerly incarcerated mothers and their children's caregivers. There is no charge for legal representation. Intakes are scheduled by appointment only. CLAIM cannot provide criminal defense legal representation.

In **Criminal Law**, CGLA represents defendants on both misdemeanor and felony charges, but only on cases in particular courtrooms (contact the office for details). CGLA also represents juveniles in delinquency cases and school suspension/expulsion proceedings.

In **Criminal Records**, CGLA helps individuals clear their criminal backgrounds by applying for expungement and sealing, health care waivers, certificates of rehabilitation and executive clemency.

CGLA has a Help Desk for expungement and sealing on the 10th floor at the Richard J. Daley Center, Room 1006, Monday through Thursday, 9 a.m. to 12 p.m. and Thursday afternoons from 1 p.m. to 4 p.m. A maximum of 25 people signed each day receive services. CGLA also operates a Help Desk for expungement and sealing in the Sixth Municipal District (Markham courthouse), Room 102J on Wednesdays from 10 a.m. to 2 p.m. In collaboration with LAF, CGLA staffs a Juvenile Help Desk on the 1st Floor of the Juvenile courthouse at 1100 S. Hamilton. Hours are Mondays, Tuesdays, and Thursdays, from 9 a.m. to 4 p.m.

In order to qualify for CGLA's services in-house (not at the Help Desks), clients must be Chicago residents and have household incomes that fall below 150% of the federal poverty level. Potential clients for criminal records legal services must live in Cook County. Potential clients pay a non-refundable \$20.00 intake fee to meet with an attorney. Intakes for representation are by appointment only. We cannot accommodate walk-in appointments.

CARPLS attorneys do not represent *pro se* respondents in the administrative hearings or in court. Clients are seen on a first come, first served basis.

CARPLS also provides advice to *pro se* plaintiffs seeking to collect judgments. CARPLS attorneys provide information on the court procedures these clients are facing, as well as advice on defenses or exemptions to collection that can be raised. Law student interns and attorney volunteers also assist clients at the Collection Desk under the supervision of the staff attorneys. The Desk was developed through a partnership of the Circuit Court of Cook County, the Chicago Bar Foundation, CARPLS, and Illinois Legal Aid Online.

The Municipal Court Advice Desk provides free legal assistance to low income individuals with cases pending in the Municipal Department of the Circuit Court of Cook County (under \$50,000). The legal subject areas broadly include evictions, torts, and contracts. The Advice Desk is staffed by attorneys who interview and advise individuals regarding their legal rights and options. Volunteer attorneys, interns and law students also assist under the direct supervision of the attorneys. Services include legal advice; help with the preparation of court documents such as motions and pleadings. Referrals may also be made when direct legal representation is required and available, including through a special arrangement between CARPLS and the Chicago Legal Clinic, as well as the other legal service providers.

This Advice Desk is supported by the Circuit Court of Cook County, the Chicago Bar Foundation and CARPLS.

The Desk does not represent any clients in court and cannot offer ongoing services in contested cases. Litigants should bring any relevant court documents with them. Clients are served on a first come, first served basis. No prior appointment is necessary, but clients need to arrive early as there are a limited number of clients that can be seen each day. This Desk was developed as a joint initiative of the Circuit Court of Cook County, the Chicago Bar Foundation and CARPLS.

The Center for Disability and Elder Law (CDEL) provides free legal services to low-income seniors and persons with disabilities in Cook County on a broad range of civil legal issues, but does not provide services in criminal matters, or those involving personal injury. Representation is offered in a range of legal areas including:

Estate Planning: advance directives including powers of attorney, and simple wills

Adult Guardianship

Collections

The Center for Disability and Elder Law, in conjunction with the Cook County Circuit Court, the court's Probate Division, and the Office of the Circuit Court Clerk, administers the **Pro Se Adult Guardianship Help Desk**. The Help Desk provides information and assistance to those who wish to file a petition seeking adjudication of disability for an adult with a disability or disabilities and appointment of a Guardian of the Person for that adult without representation by an attorney (**pro se**). Volunteer staff provides assistance regarding the required court forms, process and procedures for filing a petition, scheduling a hearing, service of summons and notice and hearings for adult guardianship proceedings.

Potential *pro se* petitioners must personally come to the Help Desk, and are served on a first-come, first-served basis. Staff does not make appointments and are not available by phone.

PLEASE NOTE:

Staff at the Help Desk is not able to assist *pro se* litigants with guardianship proceedings in which appointment of a guardian of the estate will be required or which are likely to be contested, either by the respondent or any other interested person.

Staff at the Help Desk are not able to provide legal advice to potential *pro se* litigants and do not provide legal representation to petitioners in guardianship proceedings. Those who require legal advice, appointment of an estate guardian, and/or are in circumstances where the petition is likely to be contested, are provided with contact information for legal aid organizations and/or lawyer referral services that may be able to provide information, assistance, and representation.

The Desk is staffed by attorneys who provide legal advice and give assistance with simple court pleadings.

The Desk attorneys do not represent any clients in court and cannot offer ongoing services. Individuals are served on a first come, first served basis. Early arrival is recommended as there are a limited number of consultations each day. The Desk attorneys cannot answer legal questions by telephone.

The Chancery Advice Desk is a cooperative effort of the Office of the Chief Judge and the Chicago Legal Clinic, Inc.

LAS provide free civil legal services to low-income families on the following legal issues:

- <u>Domestic Violence</u> civil orders of protection and dissolutions of marriage and all issues associated with a divorce including custody, visitation, child support, distribution of property and debts, and child abductions. In August of 2017, LAS will start to represent complaining witnesses who have children in common with the defendant in their requests for orders of protection in conjunction with criminal cases heard at 555 W. Harrison. This representation is done in coordination with the State's Attorney's Office.
- **Housing** evictions, foreclosure, and Section 8 housing issues are handled.
- <u>Simple Divorce Cases</u> these cases are handled by pro-bono attorneys and the number of cases we can accept is limited. To qualify as a simple divorce case the case cannot involve domestic violence. There also cannot be any minor children of the marriage, any property issues including real estate or pensions, any debts, or any pending litigation involving the parties. The potential client also cannot be seeking maintenance.
- <u>Victims Legal Assistance Network (VLAN)</u> The (VLAN) empowers crime victims by providing a comprehensive and holistic wraparound approach to meet their legal and life needs. VLAN's holistic model features an interdisciplinary approach where attorneys and case managers work side-by-side to provide clients with a full range of services including civil legal assistance, enforcement of victims' rights, and immigration assistance. Victims

are assigned to an attorney and case manager who guide them throughout the legal and recovery process.

• Human Trafficking Initiative (HTI) – The Human Trafficking Initiative, a project of Metropolitan Family Services' Legal Aid Society, has been assisting survivors of trafficking in the Chicago area since 2012. In collaboration with local law firms, the Human Trafficking Initiative provides free, holistic legal representation to survivors of human trafficking on any legal issues related to their exploitation. The Human Trafficking Initiative assists in a variety of legal matters such as reporting crimes to law enforcements and representing them as victim/witness in a criminal or civil proceedings brought by the government, applying for immigration relief, family reunification, filing civil litigation, obtaining orders of protection, vacating and expunging criminal history that were a result of the trafficking, obtaining identification documents, and clearing financial or credit records. Additionally, the Human Trafficking Initiative works closely with community partners to connect clients to casemanagement and other programs to ensure clients have both their legal and social services needs met.
