NOTICE - TAX DEED CASES - COVID-19 EMERGENCY

This Administrative Order applies to all petitions for tax deed that were scheduled to be heard in Room 1704 for an initial hearing between the dates of March 17, 2020 and July 6, 2020 ("Delayed Petitions"). All Delayed Petitions that are still pending before Calendar 8 that have not yet been assigned to an individual calendar may be continued, dismissed or assigned to an individual calendar for hearing on the Petition for Tax Deed without further notice.

All hearings will be conducted remotely unless otherwise ordered by the assigned calendar judge.

Within fourteen (14) calendar days before any hearing on a Delayed Petition, the Tax Deed Petitioner shall give notice of the hearing to all interested parties named in the tax deed proceeding and any additional parties that have filed a written appearance pro se or through counsel. The notice shall be substantially in one of the following forms below (#1 for Remote Hearings or #2 for In Person Hearings) and sent by First Class Mail to those individuals at the same addresses listed in the proceeding, or those addresses designated by that parties' appearance, and shall include the following:
