ADMINISTRATIVE ORDER: 2021 D 2

SUBJECT: Incarcerated Litigants Program

Pursuant to General Order 2015 D 5, the Incarcerated Litigant Pilot Program was established in order to promote access to justice for incarcerated litigants in Domestic Relations Division cases in the Circuit Court of Cook County.

EFFECTIVE IMMEDIATELY, IT IS HEREBY ORDERED THAT:

1. Based on the success of the Incarcerated Litigant Pilot Program, the designation as a pilot program is revoked and it is hereby established as a permanent program of the Domestic Relations Division of the Circuit Court of Cook County. The program is expanded to allow participation in the program beyond cases in which Cabrini Green Legal Aid (CGLA) is providing legal representation to an incarcerated individual.
2. The Incarcerated Litigant Call (ILC) is for Domestic Relations Division cases where (1) at least one of the litigants is currently incarcerated and (2) Illinois has jurisdiction over the legal matter.
3. The ILC has been established primarily for litigants in either the Illinois Department of Corrections or the Cook County Department of Corrections. Litigants in other facilities may request a transfer to the ILC under the procedures below; however, if technology is not compatible, the case may be returned to the original calendar.
4. Any cases to be heard on the ILC shall only be scheduled on the predesignated dates for the hearing of such cases. For scheduling of dates and the submission of required documents, please refer to the Presiding Judge's Standing Order.¹
5. The procedure for placing a qualifying case filed in the Domestic Relations Division on the ILC is as follows:
 - a. For cases in which the Petitioner is an incarcerated individual represented by a Civil Legal Services Provider, where no substantive orders have yet been entered by the assigned judge, the matter shall be transferred from the calendar originally assigned by the Clerk of the Circuit Court to Calendar 01 upon the filing of the ILC Transfer Form.²



- b. For pre-judgment cases in which the Respondent is an incarcerated individual represented by a Civil Legal Services Provider, where no substantive orders have yet been entered by the assigned judge, the matter shall be transferred from the calendar originally assigned by the Clerk of the Circuit Court to Calendar 01 upon the filing of the ILC Transfer Form.
 - c. For all other ongoing cases in which the litigant is an incarcerated individual represented by a Civil Legal Services Provider, the litigant may file a motion before the regularly assigned calendar judge to transfer to the ILC, and, if granted, the case shall be transferred from the calendar originally assigned by the Clerk of the Circuit Court to Calendar 01.
 - d. For all cases in which the litigant is an incarcerated individual who is self-represented or represented by private counsel, the litigant may file a motion before the regularly assigned calendar judge to transfer to the ILC, and, if granted, the case shall be transferred from the calendar originally assigned by the Clerk of the Circuit Court to Calendar 01.
6. Cases transferred to the ILC pursuant to this Order shall not be deemed an exercise of statutory rights for "Substitution of Judge."
 7. ILC cases will remain on Calendar 01 until further order of court.
