GENERAL ADMINISTRATIVE ORDER NO. 2022-DV-02

SUBJECT: WEATHER EMERGENCY ON WEDNESDAY, FEBRUARY 2, 2022 AND THURSDAY,
FEBRUARY 3, 2022

Due to the inclement weather, significant snow accumulation, wind chill and the effects on travel,

IT IS HEREBY ORDERED that all criminal and civil court calls in the Domestic Violence Division, located at 555 W. Harrison, shall be continued automatically, unless the judge presiding in the Branch or Civil court orders otherwise, until February 23, 2022 (if the case was scheduled for February 2, 2022) and February 24, 2022 (if the case was scheduled for February 3, 2022) at the same time the case was previously scheduled.

IT IS FURTHER ORDERED that all Protective Orders in the Criminal Branches and all Emergency Orders of Protection, and any Motions to Extend Plenary or Interim Orders of Protection, including Stalking No Contact Orders and Civil No Contact Orders shall be extended to February 23, 2022 (if the case was scheduled for February 2, 2022) and February 24, 2022 (if the case was scheduled for February 3, 2022) at the same time the case was previously scheduled. All such orders of extension shall be transmitted to LEADS for entry.

IT IS FURTHER ORDERED that any matters that can be held via Zoom remotely shall be heard by the assigned judge.

IT IS FURTHER ORDERED that all Orders extending the hearing or status date to February 23, 2022 (if the case was scheduled for February 2, 2022) and February 24, 2022 (if the case was scheduled for February 3, 2022) shall be entered by the next date of full court operations.

IT IS FURTHER ORDERED that petitioners can seek assistance in completing petitions remotely for emergency Orders of Protection, Stalking No Contact, and Civil No Contact by contacting (toll free) 1-877-863-6338 (Illinois Domestic Violence Hotline).

IT IS FURTHER ORDERED that petitioners, advocates, or attorneys can submit their completed petitions by emailing them to the 555dv.courthouse@cookcountyil.gov email address by 4:30pm. Attorneys shall submit e-file stamped copies of the petition to the email provided above. A petition shall be considered complete only if it is accompanied by the following documents and information:

1. Domestic Violence Coversheet - **Form CCDV 0601**
 - a. Petitioner's and Respondent's name
 - b. Date of birth for both parties (if known to Petitioner)
 - c. Attorney/Pro Se information block completed
2. Summons/Alias Summons - **Form CCDV 0100**
 - a. Petitioner's and Respondent's name
 - b. Date of birth for both parties (if known to Petitioner)

- c. Respondent's USPS address
3. Protective Order Information Sheet for Sheriff Department – **Form CCCR 0100**
4. Petition for Order of Protection
 - a. Petitioner's and Respondent's name
 - b. Date of birth for both parties (if known to Petitioner)
 - c. Additional Affidavit attached if necessary
 - d. Attorney/Pro Se information block completed
5. Emergency Order of Protection
 - a. Petitioner's and Respondent's name
 - b. Date of birth for both parties (if known to Petitioner)
 - c. Attorney/Pro Se information block completed
6. Certification of Exemption from E-filing for Pro Se Litigants - **Form EWC3401**
 - a. Petitioner information block completed

IT IS FURTHER ORDERED that the Clerk of the Circuit Court of Cook County shall send notices to all litigants of the continued date of February 23, 2022 (if the case was scheduled for February 2, 2022) and February 24, 2022 (if the case was scheduled for February 3, 2022).
