The State's Attorney's Office is Involved in My Case: What Does That Mean For Me?

The Cook County State's Attorney's Office does not represent either parent in your case.

Who does the State's Attorney Represent?

The Cook County State's Attorney's Office represents the Illinois Department of Healthcare and Family Services (HFS) through the federal IV-D program. Where HFS becomes involved in the collection of child support, they do **not** act as the attorney for the parent receiving child support. They act on the state's behalf as a separate party to the action, just like each parent is a separate party to the action.

What legal issues does the State's Attorney address?

- Establishment of paternity and child support
- Establishment and enforcement of medical insurance
- Collection, enforcement, and modification of child support

Either parent can visit www.illinois.gov/hfs/childsupport or call HFS at 1-800-447-4278 to learn more about the program and whether the State's Attorney may be able to participate in your case.

The State's Attorney does not address any other legal issues that may arise in your case.

You or the other party may choose to bring other legal issues to the Court's attention, such as:

- Parenting time (formerly known as visitation)
- Allocation of parental responsibility (formerly known as custody)
- Collection of college or post-secondary educational expenses

The State's Attorney will not present these questions to the court. Rather, bringing these issues to the court's attention requires you to prepare, file¹, and present your own pleadings.
