### **Change Strategies: Decreasing Violence in the Chicagoland Area**

On January 19, 2017, Chief Judge Timothy C. Evans and Superintendent Leonard B. Dixon convened The 2017 SUMMIT entitled Change Strategies: Decreasing Violence in the Chicagoland Area. Judicial leaders, policy makers, civic community representatives, schools, nonprofit organizations, residents of the detention facility, law enforcement, defense counsel and public media discussed strategies to decrease violence.

The 2017 SUMMIT intended to: (1) Raise the issue of youth violence in Chicagoland, (2) Identify the symptoms and causes of the violence, (3) Increase the capacity of partners from the municipal, state and federal level to more effectively prevent youth and gang violence, and (4) Maintain the current efforts and systems changes in place.

Over 200 participants attended the inaugural Summit and recommended strategies, inter-

ventions or accomplishments to move Chicago forward in combatting violence. Participants recommended using the evidence-based initiatives that address: trauma-based care, family support, wraparound models, balanced and restorative justice, peace circles, addressing disproportionate minority confinement and deinstitutionalization of juvenile offenders. Speakers noted that leaders must keep their eye on the prize and not become regressive because of community violence. Summit participants recommended ten (10) solid action steps for the Chicagoland community to embrace.

Superintendent Dixon encouraged the participants to move forward after the work done at the Summit and remember that Chicago is our home. In follow-up, Dixon will convene an action committee of SUMMIT representatives to prioritize the recommendations and disseminate the findings to local stakeholders.

Residents and their families appreciated the Pope's mementos. The Rosaries will be safeguarded by the residents' parents/ guardians, while the residents were allowed to keep their card as a remembrance of the ceremony.

# "Worship and Lunch" with Parents

"Worship and Lunch" with Parents is a program where JTDC staff and stakeholders work together in an effort to promote relationship building with residents, their families and community based agencies.

On March 26, 2017, the Worship and Lunch included musical presentations by Jesus Word Center Church, an enriching message by Pastor Diane Body from Life of Peace International Ministries titled "Hidden Figures" and a family fellowship program lunch.

The successful program included 34 residents, 21 parents/guardians, 21 community guests and 20 JTDC staff. Parents' and residents' response was positive noting they enjoyed the sermonette and choir,

and more importantly, the ability to share time with their families in such an empowering environment of hope and encouragement.

A member of the Jesus Word Center choir felt inspired to share that her son was once held at the JTDC, and he has since changed his life around. Her son currently works for United Airlines, has his own home, a vehicle and gives back to his community. This was a message to the youth in attendance that there is still time and that this set back does not have to stop them from making and reaching the goals they embrace.

Residents' parents inquired about the next "Worship and Lunch" and program because it offered family time that goes further than just a regular visit, "gives a feeling of my child being home" and it allows

families the opportunity to bond in a way they never have.

This event could not have come together and been completed successfully without the help of Resident Daily Life, Programs and Professional Services, Admissions, Security and Control and JTDC Administration.

On Saturday February 4<sup>th</sup>, Congresswoman Maxine Waters, Democratic Representative for California's 43rd congressional district, attended the retreat and spoke to the young women about building a sense of community, gaining knowledge for themselves, and being creative on their ways to success.

# Resident Management Information System (RMIS)

**RMIS** is the management system for resident and staff processes at the JTDC. RMIS includes Intakes and Releases, resident demographics, contacts, gang information, court cases, appointments, case management information, Incident Reports, resident disciplinary reports, hearings and grievances. RMIS also houses Internal Investigations, JTDC headcounts and shift logbooks/reporting.

#### The future for RMIS

Additional modules will be incorporated in 2017, to include employee discipline and JTDC equipment distribution (keys, hand-cuffs, etc.). JTDC administration will use RMIS for data-driven decision making, to improve the ability to capture and report on internal processes, to make informed decisions and increase safety and program effectiveness.

#### What is important to JTDC Employees?

RMIS is fast and easy for staff to interact with when entering data. It is customizable and meets internal process needs

while being flexible to respond to ad hoc report requests. RMIS also integrates with county and internal systems (i.e., medical records system, the juvenile probation system and Guardian, JTDC's system that tracks resident safety and security checks).

#### **How does RMIS Benefit JTDC?**

RMIS increased JTDC's capacity to implement an effective case management model through easier scheduling, planning, and documentation of family sessions and case planning and collaboration with Cook County Juvenile Probation.
