# PAY BY PHONE

To pay by phone for fines or for Office Services, using a credit/debit card, YOU WILL NEED THE TRAFFIC TICKET OR CASE NUMBER, the Amount Due, and the PROVIDER# and PRODUCT ID#\*; then call:

### TO OBTAIN OLD TRAFFIC TICKET NUMBERS OR THE CASE NUMBERS TO PAY FINES OR FOR CIVIL CASE TYPE SERVICES:

Go to [www.cookcountyclerkofcourt.org](http://www.cookcountyclerkofcourt.org) or download the "Court Clerk Mobile Connect" MOBILE APP to search by name (for traffic ticket and case numbers) or driver's license number (for traffic ticket numbers). Then call or email the appropriate Division/Department/District (*listed, right*) to either order the Office Service and/or get the amount due for the fine or service.

For most NEW Traffic Tickets you can use the online "Pay Traffic Ticket" system to Pay, or Request a Court Date or Traffic Safety School. Go to:

### TO OBTAIN CRIMINAL CASE NUMBERS TO PAY FINES OR FOR CRIMINAL CASE TYPE SERVICES:

Call or email the Division/Department/District (*listed, right*) where the case was heard, provide the Defendant's name and birthdate, obtain the Case Number, and either order the Office Service and/or get the amount due for the fine or service.
