- 4 Pretrial release
- 5 Case processing
- 6 Disposition/sentencing
- 7 Post-conviction/supervision

Identifying the Problems



Cook County Data

- Average length of Stay: ~68 days
- Jail population: 8,201
- Racial Disparities: 73% Black, 11% White,16% Hispanic

Safety and Justice Challenge





An initiative to reduce overincarceration by changing the way America thinks about and uses jails

Why the Safety and Justice Challenge?

Local jails 11,700,000



State & federal prisons 631,000

ADMISSIONS

There are nearly 12 million

jail admissions annually—equivalent to the populations of New York City and Los Angeles combined, and almost 19 times the annual admissions to state and federal prisons.

Why?




CONVICTIONS

Nationally, three out of five people in jail are

legally presumed innocent,

awaiting trial or resolution through plea negotiations. In Cook County about 90 percent of jail inmates are awaiting trial.

Why?



RACIAL DISPARITIES

Nationally, African Americans are jailed at almost 4x the rate of white Americans. In Cook County, 3 out of 4 jail detainees are African Americans.

Timeline of Safety and Justice Challenge

Phase 1: May 2015 – January 2016

- Data collection
- Planning
- Proposal Development

Phase 2: May 2016 . . .

- Core and partner site awards
- Implementation begins
- Partner sites refine proposals (June 2017)

Building Solutions & Outcomes



Cook County SJC Strategies

- Court Reminder System
- Comprehensive Bond Review
- Emerging Adult Data Collection/Analysis
- Point of Arrest Diversion
- Enhanced Pretrial/Probation
- Improving Behavioral Health Services/Linkages for Justice Involved Persons
- Implicit Bias Training
- Community Engagement

Automated Court Reminder

- Summary: Cook County and the Circuit Court will implement an Automated Court Reminder System to notify defendants of date, time, and location of court appearances.
- Expected outcome: Projected 40% reduction in failures to appear due to court reminder

Comprehensive Bond Review

- Summary: The Comprehensive Bond Review (CBR) Pilot is made up of two separate strategies:
 - 1) a First Look review of misdemeanors cases for which I Bonds may be agreed upon; and
 - 2) a Second Look review which includes scheduled bond review hearings for individuals detained on low D-bonds.
- Expected outcome: Estimated jail population reductions of 1.9% for First Look and 2.8% for Second Look

Point of Arrest Diversion

- Summary: explore the feasibility of pre-booking diversion for low level offenses and/or persons with behavioral health needs.
- Expected outcome: TBD

Improving Behavioral Health Services/Linkages

- Summary: The strategy has two primary goals: 1) work with Cook County Health and Hospitals System (CCHHS) to train frontline criminal justice staff to improve services for justice involved persons; and 2) develop linkages between CCHHS care coordinators and justice involved persons.
- Expected outcome: Increased health care coverage of justice involved populations
