Coronavirus: Scheduling Traffic Cases in June and July 2020

WHEREAS, due to the COVID-19 pandemic the Daley Center courthouse will observe certain requirements for those individuals in the building to control the number and social distancing required.

WHEREAS, Traffic Court for the First Municipal District is located in the Daley Center and will be addressing cases in two phases, including matters to be held on Zoom videoconference.

NOW THEREFORE IT IS HEREBY ORDERED:

- 1. All Traffic Court cases for the First Municipal District (Daley Center) in rooms LL04, 401, 403, 405, 407, CL01, CL03, CL05, CL07, 402, 404, 405, 406 and 408 for the week of June 1-5, 2020 will be continued to the next court key date. All cases in rooms 407, 403, 401, CL01, CL03, CL07 and LL04 will be continued for the month of June and until July 6, 2020 to next key date. The Clerk's Office shall provide notice to the defendant with the new court key date, time, and Zoom information for the case.
- 2. Phase 1 will begin on June 8, 2020 for Courtrooms 402, 404, 405, 406 and 408 in which all cases will appear only for status. The lawyer for the Defendant shall appear by Zoom for the status and use the Zoom information listed below for those courtrooms. The Defendant's appearance is excused as the matters will be for status only. Defendants who want to attend the status need to contact his/her attorney to obtain the Zoom information for the case. The appearance by Law Enforcement will also be excused from these cases. The Zoom information for the major rooms will be:

Individuals with accepted motions will be provided Zoom information with the date and time for the Zooming hearing concerning the motion. The motion will be heard over Zoom and no appearance in court will be required as the appearance will occur on Zoom. The Clerk's Office will also have a process for the Defendant to call their office at 312-603-2950, 312-603-2954, 312-603-2955 and 312-603-7329 to make a payment by phone to excuse a court appearance for payment.
- 4. Phase 2, which will begin July 6, 2020, Judges will be available in person or remotely to hear emergency matters as determined by the Presiding Judge/Supervising Judge for all traffic cases in rooms 401, 403, 407, CL01, CL03, CL05 and CL07 over Zoom. The information for these rooms will be published in an Order issued in June. The Clerk's Office shall provide notice to the Defendant with new court dates, time and Zoom information for the next court date.
