C. COURTESY COPY RULE

1. Unless otherwise ordered, courtesy copies of any filings and/or exhibits are required to be delivered at least 7 (seven) business days before the scheduled hearing date via e-mail (unless directed otherwise by the Court) by the moving party. Please include a copy of the last order that sets the matter for hearing along with a list of materials that are included for the Court to review.
2. The Court will provide an email to send courtesy copies to at the time of presentation of a motion/petition. The Court reserves the right to request paper copies or flash drive of any and all submissions.

D. FAMILY MEDIATION SERVICES:

Any case being referred to Family Mediation Services for Mediation, Home Studies and Custody Evaluations by way of the 13.4 (f) Consolidated Referral Orders shall be emailed to the following email address:

drd.family@cookcountyl.gov. Once the order is received Mediation Services, their office will contact the parties for appointments. All orders must be filled out completely and must include the contact information and other required information on pages 3 and 4 of the order.

Note: The court reserves the right to set Pre-trial conferences and hearings in person.


