WHEREAS, Traffic Court for the First Municipal District is located in the Daley Center and will be scheduling cases including matters to be held on Zoom videoconference.

## NOW THEREFORE IT IS HEREBY ORDERED:

1. All Traffic Court cases will be scheduled for Zoom appearances unless a case is specially set for an in person Trial or Hearing. Please look for the date, time and room number on the citation so you will know the correct Zoom information. You can access Zoom over a computer with internet access or a Smartphone. - 3. Payments can be made over the phone and no physical appearance is required if you pay fines/costs over the phone. The Clerk's Office will also have a process for the Defendant to call their office at 312-603-2950, 312-603-2954, 312-603-2955 to determine the amount of the fine due. You can also call 1-888-497-8701 and you must provide the ticket number or case number, the amount due, provider number obtain at can id #5753 which you product #22530 and WWW.COOKCOUNTYCLERKOFCOURT.ORG.
- 4. For those who lack access to a computer or Smartphone contact the Clerk of the Circuit Court of Cook County to schedule a court appearance at 312-603-2937 or <a href="mailto:trafficdivservices@cookcountycourt.com">trafficdivservices@cookcountycourt.com</a>.
- 5. The Clerk of the Circuit Court of Cook County will mail/email documents to the Illinois Secretary of State after an order is entered if the status of the driving privileges change for the defendant. Also any driver's license will be mailed to the defendant if the court orders the release or if the matter is concluded by dismissal or completion of terms.
- 6. <u>DUI Evaluations</u> are conducted by Central States Institute (CSI) remotely. To schedule an evaluation contact them at <u>csischedulingcenter@catholiccharities.net</u> or 312-948-6001. After a plea defense attorneys should send the plea documents to Central States Institute (CSI if Level A) at <u>csid1@catholiccharities.net</u> or 312-603-8880 or Social Services (SS if Level B or C) at <u>nancy.root@cookcountyil.gov</u> and cc: <u>carlos.viramontes@cookcountyil.gov</u> or call 312-603-2517. All interviews and monitoring will be done remotely in lieu of physical appearances.

- 7. All law enforcement officers will be excused from court until subpoenaed or requested by the court or lawyers for hearing or trials.
- 8. <u>Jury Trials</u> will be scheduled for dates after Jurors are summoned for service.
- 9. Pleas for Misdemeanor Cases on Zoom: Pleas for misdemeanor cases on Zoom will require the defendant's signature on the Waiver of Defendant's Right to be Physically Present in Court, Jury Waiver, Sentencing Order and Assessment of Fines and Fees. These executed documents should be sent to the ASA in the room where the plea will be heard at least 24 hours in advance of the plea by sending to the email address for the courtroom listed under paragraph 2 of this order. If the Defendant fails or refuses to sign the Waiver of Defendant's Right to be Present in Court, then the case will be set for an in person plea on a date set by the court.
- 10. <u>Daley Center Information</u>: This information may change. Everyone will be screened outside the building including a temperature check and answering questions about COV19. Anyone entering the building must wear a mask and some masks may be available in the lobby. Only 4 individuals will be allowed on an elevator. The courtrooms will have protective shields and markings as to where individuals can stand or sit. Only 10 people can be in a court at one time. Social distancing will be enforced.
